of the Centrul de Drept al Avocatilor on the International Conference
"Actual problems in identifying stateless persons,
reducing and preventing statelessness"

1-2 November 2023

On 1-2 November 2023, the Centrul de Drept al Avocatilor (CDA), with the support of the UN Refugee Agency (UNHCR), organised the International Conference, "*Current issues of identification of stateless persons. Reducing and preventing statelessness.*" The event took place in the context of the Campaign, launched by UNHCR in November 2014, with the aim of ending statelessness within ten years by identifying and protecting stateless persons, addressing existing statelessness situations and preventing new cases from emerging.



Over two days, discussions on this topic were held by national and international experts, representatives of central public authorities, representatives of UNHCR, human rights defenders, and representatives of civil society. Speakers included a Member of Parliament of the Republic of Moldova and representatives of the Ministry of Internal Affairs, General Inspectorate for Migration, Public Services Agency, People's Advocate Office and Equality Council, as well as experts from national and international organizations.



Statelessness refers to a situation where a person is not considered a national of any State under operation of its law. Citizenship is one of the fundamental human rights. Holding citizenship is essential for full participation in society and is a prerequisite for enjoying one's full range of human rights. Stateless persons may have difficulties accessing basic rights such as education, healthcare, employment, and freedom of movement. Without these rights, they can face obstacles and disappointments throughout their lives. Today, statelessness affects millions of people worldwide.

According to government statistics, as of 30 June 2023, 1906 stateless persons reside in Moldova, of whom 966 were born in the country such that they are entitled to the citizenship of the Republic of Moldova. Also on the territory of the Republic of Moldova reside 1361 persons who have an undetermined legal status, meaning that their citizenship of any other states has not been confirmed.

Attending the event, the State Secretary of the Ministry of Internal Affairs, Jana Costachi, noted that existing good practices in the Republic of Moldova in the field of statelessness are internationally recognized and that the authorities are still planning actions aimed at preventing and reducing cases of statelessness in the future. Immediate activities planned by IGM include undertaking an assessment of the situation of persons holding stateless status and establishing a dialogue with them so as to confirm their status and to provide them with necessary services and assistance.



Bertrand Blanc, UNHCR Deputy Representative in the Republic of Moldova said: "UNHCR is mandated by the United Nations General Assembly to identify and protect stateless persons, and to prevent and reduce the number of stateless persons in the country. In Moldova, UNHCR fulfils its mandate by working closely with the government, other UN agencies and civil society on activities towards these ends. We have witnessed positive progress in Moldovan legislation aimed at reducing and eliminating statelessness in the country." "UNHCR is committed, pursuant to its mandate, to support the government of Moldova in 2024 in solving the phenomenon of statelessness."

At the end of the conference, the following findings were made by the speakers and conference participants:

- Addressing statelessness requires:
 - o Political will
 - A clear understanding of the statelessness situation in the country and of challenges in addressing it
 - o Clear strategy to building capacity of relevant stakeholders
 - o Multilateral involvement in resolution
 - o Inclusion of civil society and affected people

- The state has clear obligations to prevent statelessness among children and to ensure everyone's right to an identity. The right of every child to acquire citizenship is a fundamental right.
- It is necessary to develop procedures to avoid and reduce cases of statelessness at the national level, to train professionals working in this field, and to increase the institutional capacities of the authorities involved.

The following recommendations were made:

For Parliament

- Analyze the possibility of legislative amendments to facilitate the naturalization of stateless persons, in accordance with the obligations of the Republic of Moldova assumed by ratifying the 2006 Council of Europe Convention on the Avoidance of Statelessness in relation to State Succession, the 1954 UN Convention on the Status of Stateless Persons and the 1961 UN Convention on the Reduction of Statelessness.
- Adopt amendments to Law 200/2010 on the regime of foreigners so as to grant to stateless applicants rights similar to those granted to asylum-seekers under Law 270/2008 on asylum.

For the IGM of the MIA

- Assess/map the situation of stateless persons in Moldova, especially persons who
 obtained stateless status before 2012. For those persons who have since acquired
 citizenship of other states, remove them from the list of stateless persons in the
 Republic of Moldova. For persons who have not yet acquired the citizenship of
 another states (within a reasonable time), restore their citizenship of the Republic of
 Moldova, according to existing law, which provides for this procedure.
- With the support of UN agencies, civil society and local authorities, undertake a mapping of statelessness in all raions in the Republic of Moldova.

For PSA

- Verify/map the legal status of the 1,409 persons recorded in the State Register of Population as of 30 June 2023 as having an undetermined legal status and document them as necessary/possible.
- Establish the necessary procedures to ensure that the births of all children on the territory of the Republic of Moldova are registered and that birth certificates are issued, regardless of the legal status and identity of the parents.

For IGM, PSA and civil society

- In order to verify/map the situation of stateless persons and undocumented persons
 in in the districts on the left bank of the Nistru River and Bender municipality,
 establish the necessary procedures to ensure cooperation between state bodies and
 civil society representatives who have access to persons of interest living on the left
 bank of the Nistru River.
- Organize information campaigns on reducing and avoiding cases of statelessness and on documentation of the population. Integrate these campaigns into existing information campaigns.

•	Organize information and training of officials from local public authorities, social assistance bodies, NGO members and civil society on the issue of statelessness, how to reduce and avoid statelessness and the need to ensure that all persons are properly documented.
